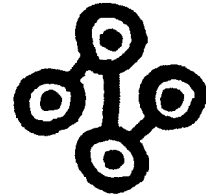

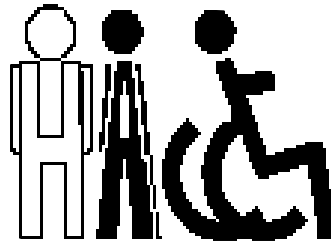

# Temporary Assistance Project

# New England Temporary Assistance Project

## *The Project*

The Temporary Assistance Project provides HACC eligible members of the community access to prompt, short-term HACC type services following hospitalisation or a crisis.

The project aims to enhance the independence of the target group and to facilitate appropriate targeting of HACC services.

## *Eligibility*

People with a long-term functional disability living in the community in the New England Area who have been assessed as having an immediate need for basic maintenance services and who have been referred to HACC services in the area for ongoing services.

## *Fee for Service*

A one off fee of \$50.00 is charged for this service. Revenue from fees is used to expand the availability of the service.

## *Duration*

A maximum of 7 hours service can be provided each week for a maximum of 8 weeks.

## *Entry Requirements*

- ⇒ HACC eligibility.
- ⇒ Evidence of referral to appropriate HACC services.
- ⇒ Awareness of, and agreement to, the temporary duration of services from the project.
- ⇒ Agreement to fee for service.
- ⇒ Completion of the TAP application.
- ⇒ Appointment of a Key Worker.
- ⇒ No other funded programme is able to provide the services requested of the TAP.
- ⇒ Referral occurs from Monday to Friday with 48 hours notice.
